## RE-OPEN SK... WHAT DOES IT MEAN FOR SHA?

### DID YOU KNOW?

- Phase 3 of the Re-open Saskatchewan plan takes place on July 11 and it will remove remaining Public Health Orders, including mandatory masking
- Guidance for the general public is not healthcare guidance and is **not intended to be applied in the health care setting** where extra precautions are necessary to protect vulnerable patient and resident populations, as well as your colleagues

### YOU NEED TO KNOW:

- **SHA will NOT be changing the current continuous masking and eye protection guidelines for Health Care Workers working in SHA facilities or performing any SHA service (ex: home care, immunization clinics)** based on recommendations from Infection Prevention and Control (IPAC).
- All staff must continue to do the **Daily Fitness for Work** screening before each shift.
- Patients, family members and visitors in all SHA facilities must continue to wear a medical-grade mask
- Exception: In SHA LTC homes and affiliates, residents, family and visitors will no longer be required to wear a mask; however it is strongly recommended, especially when a two-metre distance cannot be maintained.
- **Staff working in LTC homes MUST continue to follow continuous masking and eye protection guidelines and daily COVID-19 screening.**
- Fully vaccinated staff are still required to follow continuous masking and eye protection guidelines - COVID-19, and the Delta Variant, transmission has been documented in health care settings between fully-vaccinated people.
