COVID GUIDELINES NEED TO BE FOLLOWED WHILE AT WORK

DID YOU KNOW?

Guidance for the general public **is not health-care guidance** and is **not intended to be applied in the health-care setting**. Extra precautions are necessary to protect vulnerable patient and resident populations, as well as your colleagues.

YOU NEED TO KNOW:

It is imperative that staff continue to follow the guidelines set out by the Emergency Operations Centre, Infection Prevention and Control and the Pandemic Safety Task Force:

- SHA HCWs are strongly encouraged to get fully vaccinated (i.e. two doses) to help protect themselves and those around them.
- All SHA HCWs are required to do the [Daily Fitness for Work](#) screening before each shift — If you are experiencing even mild symptoms of COVID-19, it's important that you stay home to take care of yourself and not come to work. Coming to work could put your health, your coworkers, and your patients at risk.
- All of the health-care workforce (HCW) working in SHA facilities (even those not providing direct patient care), long-term care homes, affiliates and those performing any SHA service (ex: home care, immunization clinics) are required to continue following current [continuous eye protection/mask use](#) and [PPE guidelines](#)
- Ensure that you are still physically distancing and practicing [proper break room safety](#), which includes not sharing food or holding potlucks.
 - Being safe while taking a break applies to breaks both inside and outside
 - When you are car-pooling to work you need to be thinking of risk - ensure you are masked and have a window open for fresh air
- GET TESTED - If you are experiencing symptoms it is important that you are tested for COVID-19 — More information can be found in the [Test to Protect](#) strategy
- Continue to hold virtual meetings through Webex, [efforts should be made to reduce face-to-face](#) time to the absolute minimum and follow guidelines set out for [safe meetings rooms practices](#)
