- Conversion for the Cardinal Feeding tubes began the week of June 13th.
- The Avanos product line conversion, such as the Mickey Tubes, has been delayed as they did not have enough supply to support a startup. Product is to be available end of June and we can continue with this conversion.
- Salem sumps from Cardinal. The ENFIT VERSION PVC Salem Sump without the Anti reflux valve is available and we will begin to phase this in over the coming weeks. ENFIT Salem Sumps with the Anti reflux valve will be available the end of July and we will also begin to phase them in as well. ENFIT Silicone Salem Sumps will not be available until early 2023. Communication for all of these upcoming changes will go out with specific dates as we finalize the details.
